



## **Visitor regulations**

To protect the exhibits and our visitors, we ask that you observe the following guidelines:

- 1 Children under the age of 14 may only enter the museum if accompanied by an adult. The accompanying adult remains responsible for supervision throughout the entire visit and in all areas of the museum.
- 2 Lockers and a checkroom are available at your own risk and liability. However, visitors are permitted to take bags, rucksacks and umbrellas into the exhibition rooms at their own risk and liability.
- **3** Photography without flash is permitted for private purposes.
- 4 Animals are not permitted (exception: assistance dogs).
- 5 The consumption of food and drink is prohibited throughout the building. The bread room on the 2nd floor is an exception. Only cold food and drinks that you have brought yourself may be consumed here. The tables must be left clean.
- 6 It is not permitted to bring or use (e-)scooters, bicycles, Segways, inline skates, skateboards, handcarts or roller skates in the building. When taking baby carriages or buggies with you, care must be taken to keep escape and rescue routes clear.
- 7 Smoking (including e-cigarettes without tobacco), naked flames (including indoor flammable objects such as candles, sparklers and table fireworks) and gas-filled balloons are prohibited throughout the building.
- 8 The exhibited objects must be treated with care and not damaged. All guests are liable for any damage they cause within the framework of the statutory provisions. Intentional damage to property will be reported to the police without exception.
- 9 Only adults or children accompanied by adults are permitted to use the elevators.
- **10** The instructions of the supervisory staff must be followed.
- 11 The outdoor area is subject to its own visitor regulations.
- 12 The following special regulations apply in the Kinder-Bahnland KIBALA:

a Please fulfill your duty of supervision!

b Operable objects and play elements are to be used carefully and only under the supervision of the accompanying adults.

c Prams and baby carriages may not be taken into the Kinder-Bahnland KIBALA - this also applies to the transition from the Museum of Communication to KIBALA. A designated parking space in the foyer on the 2nd floor must be used for this purpose.

d The use of the Bread Room as part of a children's birthday party is only possible in conjunction with a booking of the corresponding offer at the DB Museum. The bread room

can be used for a maximum of one hour after the booked children's birthday party. For other family celebrations, it is necessary to book a room in the DB Museum via the rental department. Guests who hold a party in the museum rooms without a booking will be expelled immediately.

e All objects - uniforms, caps, books, suitcases, toys, etc. - may not be removed from the KIBALA; any theft will be reported.
